After receipt and acceptance of these documents by ICSSR, a formal Sanction Order for the award of the Doctoral Fellowship will be issued and subsequently the Fellowship Grant shall be transferred through PFMS to the concerned Registrar/Director/Principal of the University/Institute/College along with a copy of the sanction marked to you.
