

**MEMORANDUM OF UNDERSTANDING

**FOR IMPLEMENTATION OF SCHEME PANDIT MADAN MOHAN MALAVIYA NATIONAL MISSION ON
TEACHERS AND TEACHING
2019-2020**

THIS MEMORANDUM OF UNDERSTANDING is made on this day of **1st April, 2019** between approved **SoE/TLC/FDC/CESME/IUCTE/NCRE/SBN** located in **NIEPA/HSEs/HTs/HTDM/NITs/Central/Deemed Universities** and **MINISTRY OF HUMAN RESOURCE DEVELOPMENT (MHRD) GOVERNMENT OF INDIA** acting through **Dr. N. Saravana Kumar, Joint Secretary, Ministry of Human Resource Development (MHRD), Government of India** (*hereinafter called the 'THE FIRST PARTY'*) and **GURU GHASIDAS VISHWAVIDYALAYA** through **Dr. C.S.Vazalwar** the Coordinator, **PMMNMTT, GURU GHASIDAS VISHWAVIDYALAYA**, (*hereinafter called the 'THE SECOND PARTY'*).

WHEREAS it has been the concern of the Government of India to enhance quality of teaching and teachers in higher education to bring cohesive improvement in higher education

AND WHEREAS in pursuance of this concern, the Project objectives are:

- Preparing teachers for elementary, secondary level teachers through pre-service teacher education programs and preparing teacher educators
- Capacity building of teachers at school and higher education level
- To improve the quality of Science and Mathematics Teaching by focused training of Science and Math teachers at all levels.
- Develop experimental Science kits
- To promote discipline-specific curricula, pedagogy, learning materials (including e-content) for use by the teachers in colleges and postgraduate departments
- Enhancing opportunities of Higher Education faculty to participate in professional development programmes in order to enrich their knowledge

- To develop teachers who are able to enhance their potentials and push the frontiers of knowledge through research, networking and sharing of existing resources in the competitive knowledge world.
- To develop leadership skills in senior academic & senior functionaries at School, and Higher Education level
- Coordinating all research in teacher education through existing SoEs and departments of Education in Central and State Universities.
- To provide a platform for teacher education for integrated and coordinate approach towards holistic teacher education
- Developing new pedagogic assessment for improving teacher education
- To create a community of practitioners such as teachers and researchers, filed level functionaries in a virtual mode
- To enhance the discipline specific knowledge domain keeping in view new and global changes
- To conduct Workshop, Seminar, Conferences across disciplines so as to keep up with new findings related disciplines, pedagogy, institutional strategy and awards
- Secondary level senior functionaries given professional training to assume leadership position To promote increased interactions/collaborations with institutes/organizations World-wide working in the areas of design and innovation.
- To provide training of Higher Education faculty in latest development, new pedagogy and latest research in their specific discipline.
- To carry out any other academic activity in the domain of curricular development, pedagogic strategies, assessment tools, ICT enabled teaching learning etc.

AND WHEREAS the comprehensive description and operating conditions for the Scheme are contained in the Expenditure Finance Committee Memorandum, Minutes of the EFC and Scheme Guidelines and periodic notifications issued.

THE PARTIES AGREE AS FOLLOWS:

SECTION A:

As conditions for participation in 'THE SCHEME', 'THE SECOND PARTY' agrees to:

- The Centres would complete activities as submitted and subsequently approved by the competent authority the Project Approval Board.

- The Centres would submit an action plan and time line of activities with effect from April 1st 2019 till 31st March 2020.
- The centres shall cooperate with the Ministry and the Technical Support Group as part of all monitoring activities.
- All expenditure must be plotted on PFMS-EAT. In case of non-compliance of EAT, no funds shall be requested for the remaining period as funds cannot be released to non-EAT compliant centers.
- No financial liabilities shall accrue after the 31st March 2020.
- Complete all civil works by March 2020.
- Maintain a separate Head of Account and record of the Project Grant received from 'THE FIRST PARTY' and render annual Accounts and Utilization Certificates as per extant GoI rules..
- Furnish to 'THE FIRST PARTY' quarterly the Quarterly Progress Reports (QPRs) in the prescribed format in accordance with the procedures.

SECTION B:

'THE FIRST PARTY' agrees to:

- Release the Grant as described at Section C.
- Render or arrange to render such technical assistance and guidance as may be needed by 'THE SECOND PARTY', from time to time for an effective and efficient implementation of the Scheme.
- Monitor the implementation of the approved component, the PMMMNMTT Scheme in the concerned Institutions.
- Take corrective actions with regard to the non-performing institutions.
- Review the findings of audits and maintain the policy reforms and conduct evaluation studies.

SECTION C:

- THE FIRST PARTY' will release funds towards the approved funds of the Institution in installments on the basis of progress and performance against eligible activities. Disbursement of Grant to the Institution will be based on expenditure made and unspent balance lying with the institutions.

SECTION D:

The Project implementation schedule:

- The Scheme became effective in December, 2014 and the approval for the School of Education component was approved in 10th PAB Meeting held on 20th December, 2017.
- The Project is expected to proceed at uniform pace and is expected to be completed in **31st March, 2020**, extension and funding can be considered by the FIRST PARTY on the basis of outcome and deliverables achieved under the component aligned with the Scheme objectives and next Expenditure Finance Committee Recommendations

SECTION E:


- By this Memorandum of Understanding both parties affirm their commitment to carry out the activities and achieve the objectives mutually agreed upon.
- Any dispute between the parties shall always be resolved by mutual consultation without any resort to arbitration or other form of legal remedy including resort to Court of Law.
- This Memorandum of Understanding will continue to be effective up to the closure of the Scheme, on an annual basis.
- Adherence to the implementation of the MoU will be monitored Annually.
- Amendment to this MoU, if required, shall be carried out in writing duly authenticated and executed by both the parties.


