The Counselling Schedule for admission in M. Sc. Chemistry for the session 2019-20 is as under:

Department of Chemistry, GGV	July 12, 2019 (Friday) Reporting time : 10:00 am to 12:00 noon
For OBC Category: Candidates secured marks in VET merit list from 44 to 40	
For EWS Category: Candidates secured marks in VET merit list ≥ 31	

EWS category candidates who have not mentioned their category in the VET-2019 application and having valid EWS category certificate (as per Govt of India) are eligible to participate against EWS category vacant seats. Even though they have participated in the earlier counselling.

Candidate must report within reporting time. After reporting time, no candidate will be allowed to participate in the counselling.

*Horizontal reservation to Persons with Disability (PwD) candidates in each category shall be available as per GOI norms.
Eligible candidates are invited along with the original documents and two sets of photo copies of the following documents:

1. Hard copy of VET Application form (May be downloaded from university website)
2. Mark sheets and certificates of 10th, 12th and B.Sc.
3. Transfer Certificate**, Character Certificate and Migration from the last Institution.
4. An affidavit (if applicable) in case of gap
5. Valid caste certificate ST/SC/OBC (for claiming admission under reserved category as per GOInorms)
6. Income certificate for non-creamy layer OBC candidates issued by competent authority within 06 months.
7. EWS category candidates should produce valid certificate as per GOI rules.
8. PwD certificate (if applicable)
9. Medical fitness certificate (compulsory to be submitted within 10 days after admission).
10. An affidavit in anti-ragging format (compulsory to be submitted within 10 days after admission).
11. Aadhar card

12. Three passport size coloured photographs.
13. Banks Account Details with branch and IFSC code.
14. Fees payment should be made through Debit Card/ Credit Card / Online banking on the same day of admission



Merely attending in Counselling does not guarantee admission in course.


Requisite Fee for Admission:
