2. Candidates are required to send through mail the following documents. Only colour scanned documents will be considered.   - a. Certificates & Mark sheets of 10th, 12th, Graduation and Post-graduation (all semester/Years) from recognized board/University.
  - b. NET / NET JRF / SLET qualified certificate / Teacher Fellowship holder/ GPAT/ JEST / RGNF / DST-Inspire (Applicable to VRET exempted category).
  - c. Transfer certificate, Character Certificate, Migration certificate, Gap certificate (if any).
  - d. Passport size colour photograph
  - e. Valid Caste certificates (if applicable) as per Government of India rules.
  - f. Valid NOC from present Employer if employed.
  - g. A copy of application form submitted online by the candidate along with the receipt of fee paid while applying online.
  - h. Admit card in case of VRET category.

i. Any other document which they wish to show.

**3. a.** Interviews will be conducted online and candidate has to be prepared for the interview/presentation with all necessary arrangements. University will not be responsible for any technical problems or link failure at the time of interview. **Link of online interview/Presentations will be provided to the candidates through their email id provided in the admission form in due course.**

**b.** Online provisional admission will be given to the selected candidates after the interview on schedule date. Admission will be confirmed by the Department only after physical verification of documents during Pre-Ph.D Course Work. Mere appearance in the entrance test/ interview or securing a place in merit/ selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfils the eligibility conditions with necessary supporting documents. If an applicant is inadvertently allowed to appear in interview who otherwise does not fulfil the minimum eligibility requirements with supporting documents, he/she cannot, at a later date use the permission as a right to claim that he/she meets the eligibility requirements of VRET/ VRET exempted category.. His/her admission will be cancelled by the university without any prior notice.

**4.** The list of selected candidates will be declared between 29/07/2020-31/07/2020. All the selected candidates on the merit list are required to deposit the admission fee only through online net banking from 06.08.2020 to 11.08.2020 and complete the admission process.

**5.** If any seat remains vacant wait listed candidates can take admission by depositing the required admission fee only through online net banking between 12/08/2020-14/08/2020.

**6.** The list of selected candidates will be displayed on the notice board of the department and university website. Candidates are requested to visit the university website regularly for admission related information.

**7.** The admission of a candidate can be cancelled due to ineligibility of the candidate / due to any other valid reason including human error in preparing list at any time even during the course.
