Para 02 of the Ordinance No. 30 of GGV may be read as-

The University shall not accept the endowment whose corpus is less than the amounts as mentioned below-

- a. For institution of Gold Medals- The minimum donation shall be Rs. 3,00,000.00 (Three Lacs) per medal.
- b. For institution of prize- Minimum Cash Prize will be Rs. 10000.00 (Ten thousand) and endowment Rs. 200000.00 (Two lacs)  
Endowment for prize Rs. = Amount of Prize x 30
- c. For institution of Scholarship  
For Under Graduate Scholarship – For minimum amount of Scholarship of Rs. 1000.00 (One thousand) per month, and endowment of Rs. 300000.00 (Three Lacs) is required.  
For Post Graduate Scholarship – For minimum amount of Scholarship of Rs. 2000.00 (Two thousand) per month, and endowment of Rs. 500000.00 (Five Lacs) is required.  
For Higher Scholarships the endowment Rs.= 250 x Scholarship amount
- d. For institution of Chairs- The minimum donation shall be Rs. 2,00,00,000.00 (200 Lacs)
- e. For Memorial Lecture series- The minimum donation shall be Rs. 20,00,000.00 (20 Lacs)
