Rules for Lateral Entry

I. Proposed Structure of lateral entry equivalence committee

The equivalence committee who look after the lateral entry is proposed as follows-

- 1. Professor Chairman (To be nominated by HVC)
- 2. Professor Member (To be nominated by HVC)
- 3. Associate Professor Member (To be nominated by HVC)
- 4. Assistant Professor- Member (To be nominated by HVC)
- 5. Assistant Registrar (Academic)- Presenting officer
- 6. Dean (Concern School) Member
- 7. HOD (Concern Department) Member
- 8. Senior Most Faculty (Concern Department)- Member

The members from S. No. 01 to 04 shall be nominated by the Vice Chancellor for the term of three years. The Assistant registrar (Academic) will be the presenting officer. The members from S. No. 06 to 08 shall be the faculty members of the concerned School/Department.

I. Lateral entry at GGV

University Grants Commission (Establishment and Operation of Academic Bank of Credits in Higher Education) (I Amendment) Regulations, 2021 made the following amendment to the previous Regulations:

New amendment replacing the above:

In sub regulation 1 of the Regulations 7 of the principal regulations following shall be substituted, namely: (I) Universities and Autonomous Colleges satisfying sub-regulation (2) of Regulation 1 and the Institutions of National Importance as declared by the Government of India and specially empowered by an Act of Parliament to confer or grant degrees. The sub regulation 2 of regulations 7 shall be omitted.

Accordingly, Guru Ghasidas Vishwavidyalaya will

- Accept in principle lateral entry of students from outside the University for an ongoing UG/PG programme at GGV from AY 2024-2025. The number of seats will be not more than 10% of original intake plus consequential vacancies.
- 2. The candidate should apply online/offline to the department where he wants to take lateral entry.
- 3. The concerned Head will prepare a list of the applicants with all related documents and will submit to the equivalence committee.
- 4. The equivalence committee will examine the eligibility based on the documents submitted by the candidate and will submit the eligibility cum equivalence report after the approval of the competent authority to the Head of the concerned Department.
- 5. The Head of the Department will prepare the merit list on the basis of criteria as mentioned in University regulations and as per the guidelines of other regulatory bodies.
- 6. The Departmental admission committee will recommend the candidate for admission and will submit the list of candidates seeking admission through AR (Academic) for competent approval.

- 7. Reservation for lateral entry may be considered as per Constitutional provisions by pooling of seats and rostering.
- 8. Open individual courses in various academic units for enrolment by students outside the University for a fee to be decided by the University. Such courses should be offered online using the services of the Centre for Distance and online education, GGV (CDOE) and its resources.
- 9. The candidates should also refer the Regulations for "Credit Transfer Policy", "Multiple Entry and Exit" and all regulations of the all professional bodies issued and amended from time to time.
