## Agenda with permission of chair

AA Item No.1 Consideration upon the sealed envelopes of Selection Committee meeting held between 12.09.2019 to 14.09.2019.

The Executive Council noted that the interviews for various positions of the Forensic Science Department were conducted between 12.09.2019 to 14.09.2019, including the positions of Assistant Professor (2 UR, 1 SC, 1 ST, 02 OBC and 01 PH-OH).

Also that one of the applicant had filed a case before the Hon'ble High Court of Chhattisgarh vide WP(s) No. 7443/2019, wherein the Hon'ble High Court had directed that the petitioner be also allowed to participate in the interviews, but, the result of the interview shall not be published and declared without the leave of the Hon'ble High Court. Hence, in compliance of the directions of the Hon'ble High Court the results for the position of 02 UR and 01 SC were withheld as the applicants for these positions were under challenge.

Further that, the matter was dismissed by the Hon'ble High Court vide order dated 07.04.2025 and stating that the order 13-9-2019 has lost its efficacy, hence, it is recalled and now it shall not be beneficial for the petitioner in any manner.

**Resolved that,** since the interviews were conducted in September 2019 and normally the recommendations of Selection Committee are valid for a period of one year, however, a considerable time of almost six years has elapsed since the interviews have taken place; therefore, the Selection Committee proceedings with respect to the positions of Assistant Professor 02 UR and 01 SC for the Department of Forensics Science, conducted between 12.09.2019 to 14.09.2019 be annulled and a fresh advertisement be published for recruitment of these positions.

The meeting ended with vote of thanks to the Chair and Hon'ble members.
