Memorandum of Understanding

- 1. The memorandum of understanding made this 30, March 2022 between, Department of Forestry, Wildlife & Environmental Sciences, GGV, Bilaspur (hereinafter called "third party". Which expression shall where the context so admit, be deemed to include its successors executors and administrators) of the one part and the Chhattisgarh Compensatory Afforestation Fund Management and Planning Authority (herein after called "Chhattisgarh CAMPA", which expression shall, where the context so admit, be deemed to include it successors in office and assigns) of the bother part.
- 2. Whereas the third party has agreed with the Chhattisgarh CAMPA to provide required services for monitoring and evaluation of CAMPA works executed by Chhattisgarh CAMPA under APO 2018-19, which have been furnished vide letter No/CAMPA-02/S.O./13/2022/1833 dtd. 26/03/2022 by the Chief Executive Officer (CAMPA), Chhattisgarh.

The rate quoted by Department of forestry, wildlife & environmental sciences, Bilaspur is Rs 40 lakhs (Rs forty lakhs only) for the aforesaid services. The amount is exclusive of all taxes. The taxes applicable in this case shall be borne by the Chhattisgarh CAMPA.

- 3. The letter No/CAMPA- 02/S.O./13/2022/1833 dated 26/03/2022 issued by the Chief Executive Officer (CAMPA), that describes the CAMPA works executed by Chhattisgarh CAMPA under APO 2018-19, shall also form part of this agreement.
- 4. (a) Various types of plantation established and civil works constructed under the CAMPA shall be evaluated quantitatively and quantitatively with standard methodology as mentioned vide letter Letter No/CAMPA-02/S.O./13/2022/1833 dated 26/03/2022. Sampling stratification will be Division-wise and on the basis of plantation types i.e Compensatory plantation, Wildlife management plan and other mandatory works, works done under 80% of NPV like all types of Plantation, Cleaning of bamboo, Improvement of growing stock in orange area, Boundary wall, Chainlink fencing, Sacred groves etc and work done under 20% of NPV like Construction of nursery, Upgradation, Expansion of nursery, Upgradation of timber depot, Construction of hitech barriers, Upgradation of forest road (WBM), Pul-Puliya, Construction of official and Residencial buildings etc.

(b)GPS coordinates of the location of the sites shall be recorded and photographs of the area shall be taken along with the date during field visit for M & E by the third party.

- (c) The monitoring and evaluation parties shall intimate the concerned Divisional Forest Officer prior to commencing their works so as to enable the field functionaries to coordinate and make necessary preparation for verification of records and evaluation of field works.
- (d) DFOs or any other officer/officials nominated by the CGFD shall provide the relevant documents/records and information of their respective area for verification. The concerned staff of the Forest Department shall provide assistance in the field during the M & E, works.

- (c) Chhattisgarh CAMPA shall provide 50% of the M&E charges in the 1st installment prior to commencement of works, 40% in the 2nd installment after completion of 50% of M & E works, and the remaining 10% in 3rd installment after submission of reports.
- (f) Duration of M&E will be 06 months from the date of execution of the MoU (excluding rainy scason). In case of extension of duration, if required by the third party, it shall be decided in consultation with the Chief Executive Officer (CAMPA) Chhattisgarh, Raipur.
- (g) In case any work to be excluded from M&E due to law and order problem or other unavoidable reason, decision shall be taken by the third party in consultation with the Chhattisgarh CAMPA, M&E charges for the concerned excluded works shall be deducted proportionally.
- (h) Data/information collected for M&E shall remain as property of Chhattisgarh CAMPA.
- (i) Data collected during M&E shall neither be published in any note be made public. Secrecy of the data shall be fully maintained.
- 5. This MoU is at will and may be modified by natural consent of authorized officials. This MoU shall become effective upon signature by the authorized officials from the both the parties and will remain in effect until modified or terminated by any one of the partners by natural consent.

6. All disputes arising out of this agreement and all question relating to the interpretation of this agreement shall be decided mutually.
