## REPORT OF FIRST INTRA NEGOTIATION COMPETITION



Alternative Dispute Resolution Cell (ADRC), a newly established student committee supervised by faculty members of which the Coordinator is Mr. Sudhansu Shekhar Bisen, hosted 3 days Negotiation Competition under the convenorship of Dr. Sagar Kumar Jaiswal. This event served as a testament to the ADRC's commitment to its mission, i.e., to enable students to learn the art of alternative dispute resolution mechanism.

The competition revolved around the dispute between two corporate giants in the technology industry: one is a renowned hardware manufacturer, and another is an innovative software development company. These companies had embarked on a joint venture to create a groundbreaking smart home system that combined the features of both hard ware and software. Their collaboration was governed by a Joint Venture Agreement (JVA) that defined profit-sharing, intellectual property rights, project milestones, and dispute resolution mechanisms. However, as the project progressed, conflicts emerged. Disagreements over responsibilities, delays in achieving project milestones, and disputes about ownership of critical intellectual property arose, making the situation very much complex. One party went to the court, but the court mandated the disputes be resolved through Alternative Dispute Resolution Mechanism.

Although the event commenced on 17<sup>th</sup> of October but in reality, it started much before than the starting day. As the success of this event required that students must be sufficiently trained,



therefore, in order to make them enable, the ADR cell, by using the resources of Nidhi Madam, has organised one day workshop on 12<sup>th</sup> of October, on the topic "The Art of Negotiation in Mediation Proceeding". For this purpose, Shri Harish Purohit ji, a Senior Advocate of High.

Court of Rajasthan, was invited for gracing the occasion. And he wonderfully delivered an online lecture on this. This educational event equipped our students with valuable skills in the field.

To make participants and students more enabled, ADR Cell organised one more workshop, this time on "The Art of Procedures of Arbitration Proceedings. It was an offline workshop, and was conducted on 13th of October, and Shir Ashok Kumar Panda Sir, A Retired District Judge





and former Registrar of Hon'ble High Court of Chhattisgarh, graced the occasion. This session also enabled our students and participants. I congratulate Mr. Apurva Azad, a student coordinator of this event, who manage hard to bring him in our department.

Then come the date of commencement of negotiation competition, everyone was are waiting

In its augural ceremony, head of department, Dr. Ajaiy Singh did a wonderful job, and it is because of his effort that the department witnessed presence of Advocate General of Hon'ble High Court of Chhattisgarh in our department. Shri Satish Chandra Verma Ji, the said advocate general, graced the occasion, encouraged our students, and also cut a ribbon for starting of the Negotiation



Competition. He also gave the tips to our participants.

This Negotiation Competition aimed to create a platform where participants could enhance their negotiation skills and foster the spirit of teamwork and diplomacy. And certainly, during these three days the department witnessed some of the brightest legal minds engage in fierce yet constructive negotiations. This Intra Negotiation competition brought together 84 numbers of students across 3rd, 4<sup>th</sup> and 5th years students. Where 3<sup>rd</sup> year students played roles of clients, 4th years students—mediator, the role of counsel and coach were played by the students of 5th year.

Two clients, one mediator, three counsel, and one coach constituted one team, thus total 12 team were involved in this competition. And total number of matches among team including semifinal and final were **fifteen**. The teams who played a final round matches actually were involved in 4 matches.

These teams **showcased** their skills not only in negotiation but also in adaptability, creativity, and problem-solving. It was cheering to witness the passion and dedication of each participant, who contributed to the success of this event.

The competition comprised two preliminary rounds, one semi-final round, and one final round. Each round presented a unique set of challenges designed to test the negotiation skills of the participants. The scenarios and case studies were carefully crafted to reflect real-world negotiation situations, including legal disputes, business transactions, and diplomatic affairs.

The judges, who actually are faculty members and research scholars, and among them whom some have practical experiences in the field of negotiation, have played a pivotal role in ensuring the fairness and objectivity of the judging process.

The responsibility of conducting the round was posed on Moderator, and I, without any hesitation, can say that these moderators, who actually are our students, they have done wonderful job, have kept the business of conducting the round, regularly instructing and within control.

Throughout the competition, the department have observed remarkable performances, creative negotiation strategies, and excellent teamwork. The winner and the participants both deserved congratulations for showing their dedication and hard work. Their commitment to this competition has set a high standard for future events.

Following the final round match, that was held on the morning of 19.10.2023, the department witnessed valedictory session. The session was graced by the presence of Hon'ble Vice Chancellor, Prof. (Dr.) Aloke Chakrawal, and Registrar, Prof (Dr.) Manish Srivastava, who were the Chief Guest and Guests for both opening ceremony of Computer Lab in the department and the Valedictory Session, respectively. While appraising the computer lab, he was very much particular to need of the students of law. Towards fulfilling the expectation of law students he disclosed that these students will soon have access to database like Manupatra or SCC Online, as per



rule.

Their presence in the Valedictory session were marked by great honor and significance for both the faculty and students within the department, as they had the privilege of receiving words of encouragement and inspiration from these distinguished guests, further motivating them towards academic excellence.
