The event was structured into two distinct sessions. The inaugural session commenced with esteemed dignitaries, followed by an enlightening lecture delivered by the distinguished Chief Guest, the Advocate General. The subsequent session featured a deep dive into technical aspects led by accomplished research scholars.

Inauguration Session: At the commencement of the session, Professor Sudhanshu R. Mohapatra, Head of the Department, provided an insightful overview of three groundbreaking new criminal laws: the Bharatiya Nyaya Sanhita, Bharatiya Nagrik Suraksha Sanhita, and the Bharatiya Sakshya Adhiniyam. He elaborated, "The Indian Home Ministry has recently announced the enactment of these laws, slated to come into effect on July 1, 2024, effectively replacing the archaic British-era Code of Criminal Procedure, Indian Penal Code, and Indian Evidence Act." These laws signify a monumental shift in India's criminal justice landscape, emphasizing a victim-centric approach, bolstering national security measures, and introducing robust frameworks for digital/electronic evidence review. Professor Mohapatra underscored their pivotal role in modernizing and revitalizing the Indian legal framework.

Session by Chief Guest (Advocate General Mr. Praful Bharat): After that, the Advocate General addressed the session by shedding light on the intricacies of recent legal reforms, emphasizing the necessity for adapting laws to the evolving societal landscape. The new laws overhaul the Indian criminal justice system. They aim to revamp and replace the dated colonial laws, by considering implementation of justice through a victim centric approach, increasing focus on national security
