4. The expenditure involved is debitable to **Fund for Science & Engineering Research (FSER)**. This release is being made from SERB International Research Experience (SIRE) Programme Budget.

11. The institute will maintain separate audited accounts for the project.


12. The SIRE awardee will also submit a Report on the work done during the visit and Boarding Pass to SERB.
