INTRODUCTION TO SCHEME : MNREGA (Mahatma Gandhi National Rural Employment Guarantee Act) is an Indian labour law and social security measure that aims to guarantee the right to work. It was proposed in 7th september 2005 as NREGA and renamed to MNREGA in 2009. MNREGA was implemented in phases, starting from february (2006 process) 2009 and at present it covers all districts of the country with the exception of those that have a 100% urban population. The Act provides a list of works that can be undertaken to generate employment and also create assets, water conservation, drought proofing, land development, flood control and connectivity. It was initiated with an objective of wage employment generation and enhancing livelihood security in rural areas by providing at least 100 days of guaranteed wage employment in a financial year to every household.

OTHER MAIN OBJECTIVE OF MNREGA

- ② It aims directly at addressing causes of chronic poverty.
- ② Strengthening of local bodies through giving a significant role to Panchayati Raj Institutions in planning and implementation of work
- ② To prevent migration of rural people to urban areas for employment opportunities.
