

### Important instructions to candidates

1. All qualified candidates of VRET/ VRET (Exempted) 2024-25 are eligible to appear in an interview as per the schedule mentioned above subjected to document verification of eligibility before interview.
2. The candidate has to be prepared for Interview / Viva-Voce and **Research Proposal Presentation (Power Point Presentation)** with all necessary arrangements.
3. Provisional admission will be given to the selected candidate after interview on scheduled dates. Admission will be confirmed by the department only after physical verification of documents at any time/during Pre- PhD Course Work as required by the department. Mere appearance in the Entrance Test/interview or securing a place in merit/selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents. If an applicant inadvertently allowed to appear in interview who otherwise does not fulfills the minimum eligibility requirements with supporting documents, he/she cannot, at a later date, use the permission as a right to claim that he/she meets the eligibility requirements of VRET/ VRET (Exempted). His/her admission will be canceled by the University without any prior notice.

4. Non-NET Fellowship will be released only to the VRET candidates only after confirmation of Admission of the candidates. No claim shall be entertained in this regard.
  5. Candidates should present their presentation in not more than 10 slides including first slide as his/her name, email, address, contact number followed by maximum four more slides which are focused on objectives, work plan and expected outcomes. Candidates must stick to the time allotted by DRC at the time of interview.
  6. After getting the interview invitation, the candidate has to communicate acceptance. No request for change of date and time for the interview will be entertained.
  7. At the time of reporting, the candidate must satisfy all criteria of eligibility.
  8. **Candidate must bring following original documents and one set of xerox copy, at the time of interview: 10th ,12th, UG, PG marksheets, NET/GATE (if any), TC/CC, Caste (ST/SC/OBC-NCL, as applicable) / PWD certificate (if applicable), latest income certificate issued during 2024-25 for OBC-NCL (if applicable), NOC from employer is mandatory for working professionals, and downloaded application form.**
  9. NOC produced by the working professionals must be in the University prescribed format available in the web page [www.new.ggu.ac.in/admission\\_news/22](http://www.new.ggu.ac.in/admission_news/22).
  10. After a candidate is recommended for provisional admission, as per the university rules, he / she will deposit the required admission fee on or before the last date through online link available in [www.new.ggu.ac.in](http://www.new.ggu.ac.in) . Candidate has to submit the receipt of fee paid to confirm his/ her admission, failing which admission will be cancelled and the concerned candidate will be responsible for this.
  11. The admission of a candidate can be cancelled due to ineligibility of the candidate / due to any other valid reason including human error in preparing list at any time even during the course.
