- ➤ All the candidates must be prepared for a presentation of a tentative research Proposal in 5-6 pages (in 8 hard copies) along with a power point presentation of the same (max 10 slides).
- ➤ Online presentation shall be considered only under an unavoidable or emergency condition subjected to the consideration of the admission committee. The candidate must seek prior permission for the same at least five days before the date of interview and must be prepared for online presentation/interview with all necessary arrangement. The online presenter must submit the soft copy (single PDF file) of all the documents as mentioned under admission process (Academic Qualification) on or before 07/04/2025 by 5pm to hodeduggu@gmail.com. Department of Education will not be responsible for any technical problem or link failure at the time of presentation/interview/viva-voce.
- All candidates who have upgraded their qualification to be eligible for admission under the VRET Exempted category must email their representation along with a proof of their latest qualification to hocenyclimage.com by 5.00 pm, 07/04/2025
- ➤ The admission process shall follow the University guidelines given from time to time.
- Mere appearance of the candidates in the presentation/interview/viva-voce shall not qualify them to be admitted in the programme. Admission to Ph.D. programme shall be subject to the availability of seats and supervisor. As per guidelines university reserves the right to fill or not fill any seat and also to alter the nature and number of seats if the circumstances so warrant as well as to cancel/refuse admission at any point of time.
