Instructions to the candidates:

- 1. The candidates have to bring/submit the following documents with two sets of photocopies along with original documents:
 - i. 10 (HSC) mark sheet (Mandatory)
 - ii.12 (HSSC) mark sheet (Mandatory)
 - iii. UG marks sheet (Mandatory)
 - iv. PG marks sheet (Mandatory)
 - v. Transfer certificate/College leaving certificate (optional), if available
 - vi. Caste Category/PwD certificate, if any (Mandatory if applied under any category)
 - vii) Valid Income certificate for OBC issued by competent authority, if applicable
 - (viii) If the candidate has applied for admission under VRET Exempted category then one document in support of exemption claimed and NoC (mandatory, if claimed)
 - ix) Copy of application form submitted online
- 2. Candidates will attend the interview on scheduled dates and will give their presentation before the DRC concerned. No TA/DA will be paid to the candidate by the University for attending interview.
- 3. All candidates must submit an abridged version of the write-up of the proposal of their research interest/plan (maximum two pages) to the HoD by 10 April, 2025 through e-mail (raja.dhruv@gmail.com)
- 4. On the day of interview each candidate has to make a power point presentation (10-15 slides) of their research proposal and have to present it within 10 minutes after which there will be 5 minutes for discussion (Total 15 minutes).
- 5. Applicants, who have not yet submitted caste certificates, income certificates etc for availing the benefit of reservation are required to submit the documents before the meeting of the DRC. An applicant who fails to submit the required documents before the DRC meeting for availing the benefits of reservation shall be considered under unreserved category.
- 5. Provisional admission will be given to the selected candidates after the interview on the scheduled date. Admission will be confirmed by the Department only after physical verification of documents. Mere appearance in the entrance test/ interview or securing a place in merit/ selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission. If an

applicant is inadvertently allowed to appear in interview who otherwise does not fulfill the minimum eligibility requirements with supporting documents, he/she cannot, later, use the permission as a right to claim that he/she meets the eligibility requirements of VRET Exempted. The admission of such candidates will be cancelled by the university without any prior notice.
