

Important Instructions to Candidates

- 1. All qualified candidates of VRET/ VRET (Exempted) 2024-25 are eligible to appear in an interview as per the schedule mentioned above subject to document verification of eligibility before interview.
- 2. The candidates are requested to come prepared for an interview through a Viva-Voce and Research Proposal Presentation (with Power Point Presentation) with all necessary arrangements.
- 3. Provisional admission will be given to the selected candidates after interview on scheduled dates decided by the University. Admission will be confirmed by the department only after physical verification of documents at any time of admission. Mere appearance in the Entrance Test/interview or securing a place in merit/selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfils the eligibility conditions with necessary supporting documents. If an applicant inadvertently allowed to appear in interview who otherwise does not fulfil the minimum eligibility requirements with supporting documents, he/she cannot, at a later date, use the permission as a right to claim that, he/she meets the eligibility requirements of VRET/VRET (Exempted). His/her admission will be cancelled by the University without any prior notice.
- 4. Candidates should present their presentation in not more than 10 slides including first slide as his/her name, email, address, contact number followed by maximum four more slides which are focused on objectives, work plan and expected outcomes. Candidates must stick to the time allotted by DRC at the time of interview.
- 5. At the time of reporting, the candidate must satisfy all criteria of eligibility
- 6. Candidates appearing before DRC are advised to report for the interview/presentation along with all relevant **Original documents and two sets** of attested copies of testimonials.
 - a) Downloaded admission form.
 - b) 10th (HSC) Mark sheet (Mandatory)
 - c) 12th (HSSC) Mark sheet (Mandatory)
 - d) UG Mark sheet (All Years/Semesters) (Mandatory)
 - e) PG Mark sheet (All Years/Semesters) (Mandatory)
 - f) Transfer Certificate/College Leaving Certificate (Optional), if available
 - g) Caste/Category/PWD Certificate, if any (Mandatory if applied under any category)
 - h) Income certificate (Issued during 2024-25) for OBC, if any
 - i) If applied for VRET Exempted, then one document in support of exemption claimed and NoC (mandatory, if applicable)
 - j) 3 Sets of Research Proposal.

- 7. NOC produced by the working professionals must be in the University prescribed format available in the web page https://www.new.ggu.ac.in/admission_news/22
- 8. After a candidate is recommended for provisional admission, as per the university rules, he/she will deposit the required admission fee immediately through a challan issued by the office of the Law Department at the time of admission, payable through any one of these modes. Debit Card / Credit Card / Online Banking only (as per fee structure). The candidate has to submit the receipt of fee paid immediately to confirm his/her admission, failing which admission will be cancelled, and the concerned candidate will be responsible for this.
- 9. The admission of a candidate can be cancelled due to ineligibility of the candidate / due to any other valid reason including human error in preparing list at any time even during the course.
