- All applicants seeking admission for PhD programme shall present their research proposal only in advertised areas of specialization.
- 11. Time limit for the presentation is 8 minutes and 2 minutes for discussion.
- 12. Applicants, who have not yet submitted caste certificates, income certificates, NOC, Experience certificate etc for availing the benefit of reservation are required to submit the documents on or before 15/04/2025 through mail. An applicant, who fails to submit the required documents on or before 15/04/2025 will be treated as not eligible.
- 13. Provisional admission will be given to the selected candidates after the interview on schedule date. Admission will be confirmed by the Department only after physical verification of documents during Pre-Ph.D Course Work. Mere appearance in the entranceest/ interview or securing a place in merit/ selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents.
