7. Caste/Category Certificate as per GOI norms, if any (Mandatory if applied under any category).
8. Latest income certificate (issued during 2024-25) for OBC/EWS, if any.
9. If applied for VRET Exempted, then documents in support of exemption claimed and NOC (mandatory) from employer.

After a candidate is recommended for provisional admission, as per the university rules, he/she has to deposit the required admission fee immediately through details issued by the office of Rural Technology department at the time of admission payable through any one of these modes: Debit Card/ Credit Card/ Online Banking only. Candidate has to submit the receipt of the paid fee immediately to confirm his/her admission, failing which admission will be cancelled and the concerned candidate will be responsible for this.
