

The Research project intends to engage you as Senior Research Fellow (SRF) with the following task:


1. The engagement will be initially for six-month duration for the date of joining and renew after that as for performance and is a purely temporary engagement, and you will not claim any permanent employment in this organization on a regular basis in future.
2. Your working hours will be from 09:30 AM to 06:00 PM and attendance will be recorded. Payment will totally be based on attendance. In case of short attendance payment will be deducted.
3. Your reporting officer will be Dr. Sanjit Kumar Project Investigator, Department of Biotechnology
4. If your work is not found satisfactory according to the Project Investigator, he will have full authority to take action against you.
5. It is mandatory for you to follow the rules of the University. In case of any indiscipline attitude your service will be terminated immediately.
6. Your working days will be from Monday to Friday except Public holidays. Due to any exigency, you are required to attend office on any public holidays and even beyond office hour.
7. Any kind of involvement in Political activities will be contrary to the Code of Conduct and your service will be dismissed with immediate effect.
8. You will be paid consolidated monthly remuneration of Rs. 35,000/- + 8% HRA p.m. as per project norms during the period of your service.
9. The remuneration will be paid by the university through bank transfer to your personal account.
10. The engagement can be terminated on a notice of **seven days** from either side or payment of proportionate consolidated remuneration in lieu thereof.
11. Unless renewed by a separate communication, the contract shall normally cease with the contract period.

16. If it is agreeable to him for the above terms and conditions he is requested to sign the duplicate copy of this order in token of his acceptance and return it to us.




