1.	2300078598	Ineligible. The candidate completed their PhD on June 11, 2024, and therefore does not have two years of post-PhD experience. Additionally, the experience certificate does not mention the pay scale, and Form 16/ITR is not attached to verify the pay scale.	
2.	2300078751	Ineligible. The two experience certificates appear to be contradictory. One states that the candidate has been working as a Professor since 10.03.2008, while the other mentions the candidate as an Associate Professor starting from the same date. Additionally, the experience certificate for the Associate Professor role does not mention the pay scale. The candidate has submitted an old, generalized NOC, which is applicable for all central universities. However, they are required to submit an NOC d	
3.	2300078768	Ineligible. The candidate has less than 6 publications, making them ineligible for the position. The experience certificate does not mention the pay scale. Additionally, Form 16/ITR has not been provided to verify the accuracy and pay scale of the experience.	
4.	2300079155	Ineligible. The candidate completed their PhD on February 10, 2024, and therefore does not have two years of post-PhD experience. Additionally, the candidate does not meet the requirement of a total of eight years of experience. The experience certificate does not mention the pay scale, and Form 16/ITR has not been provided for verification.	
5.	2300079472	Ineligible. The pay scale listed as 15600+AGP 6000 from the year 2003 is not possible as per 6th CPC, as this pay scale was not introduced until 2006. Additionally, Form 16/ITR is missing from both experience certificates, which would be necessary to verify the accuracy and pay scale of the experience.	
6.	2300085368	Ineligible. The pay was fixed on a consolidated salary basis for the entire duration of the contractual period from 29-07-2013 to 25-07-2016 and from 19-09-2016 to 18-09-2019. Form 16/ITR has not been provided to verify the accuracy and pay scale of the experience.
