#### **ABSTRACT**

Criminal investigations endeavor physical evidence analysis for personal identification to prove the presence or involvement of a suspect in a criminal act. Forensic investigators have long been using lip prints as a potential source to identify an individual in the absence of fingerprints or DNA evidence at the crime scene, especially in kidnapping cases. Lip prints are inimitable like fingerprints and classifiable into various forms that enable individualization. In past decades, numerous demographic studies have been undertaken to substantiate the importance of lip prints as corroborative physical evidence. An extensive literature review emphasized the need to reform the classification system of lip prints and study the effect of habitual and pathological conditions on the consistency of lip prints. The present study attempted to formulate an alternative system to classify lip prints and identify various minutiae to enhance the former Individual classification of lip patterns. Lip print patterns, characteristic of smokers and tobacco chewers, were also carefully analyzed. Additionally, various oral diseases and their effect on lip prints' stability were studied in detail. Lip print samples were collected from 500 healthy individuals, 50 smokers, 50 tobacco chewers, and 50 dermatology patients and digitalized for their critical analysis. A novel classification system based on Basic and Combination patterns of lip wrinkles was devised in the present study. Twenty-five new Individual features were identified and added to the former Individual classification system given by Kasprzak. Specific lip patterns like Whorl-like pattern, Firework-like pattern and Curved Short Ridges were significantly observed as characteristic patterns in Smokers and tobacco chewers. Moreover, the eruption of various non-cancerous oral pathological conditions was found to hamper the pattern of the lip wrinkles and grooves temporarily and recovered to the original form after healing. All these findings are expected to support individualization and personal identification processes in Forensics.

This synthetic opioid acts on mu-opioid receptors in the brain and spinal cord, leading to profound central nervous system depression. Its metabolism via CYP3A4 and rapid clearance from the body complicate toxicological analyses. Detection typically requires sensitive techniques such as LC-MS/MS and GC-MS, often following solid phase extraction. Forensic cases have highlighted its lethal potential, with post-mortem findings including cyanosis, pulmonary edema, and low nanogram-per-milliliter concentrations in blood. The increasing prevalence of methyl fentanyl in illicit drug markets underscores the urgent need for advanced detection tools and heightened awareness among forensic professionals.


