
Agenda 1: To discuss and approve the syllabus of vocational courses in 2nd and 4th Sem under 4 Years UG programme in Commerce.

Agenda 2: To discuss and approve the syllabus/subject of MooCs in 4th semester under 2 Years PG programme in Commerce.


Resolution: The said agenda has not been discussed due to absence of clear guidelines.


