- 1. All the candidates listed below are hereby invited for provisional admission in the 2 years LL.M. programme.
- 2. Among the candidates listed below, interested candidates, who wish to take provisional admission must pay the fee (₹ 65,450 for 1<sup>st</sup> Semester) through the Samarth portal only till 21<sup>st</sup> June, 2025.
- 3. The payment shall be made through the Samarth portal and no other payment method will be accepted for the purpose of provisional admission.
- 4. After making the payment, candidates must fill out the Google Form (link: bit.ly/45Lom9e or Scan QR code attached at bottom) to enable the department to confirm receipt of the fee.
- 5. Payment of the fee alone does not guarantee provisional admission. Candidates must meet the prescribed eligibility criteria and submit the required documents during physical verification, scheduled from 1st to 3rd July 2025.
- 6. Candidates who fail to pay the fee and do not comply with the instructions mentioned in points 1 to 4 will have their candidatureship cancelled. The vacant seats will then be offered to other candidates based on merit in the next round of admissions.
- 7. Candidates, who do not comply with the instructions mentioned in points 5, will have their candidatureship cancelled. The vacant seats will then be offered to other candidates based on merit in the 3rd round of admissions.
- 8. All the candidates who will pay fee are also required to be present for physical verification (between the dates of  $1^{st} 3^{rd}$  July, 2025) along with following mentioned docs:
  - a) 10<sup>th</sup>/HSC marksheet original and two photocopies
  - **b)** 12<sup>th</sup>/HSSC marksheet original and two photocopies
  - c) Marksheets of all Semesters of UG original and two photocopies of each
  - d) Caste/PwD/EWS/Income certificate (if applicable) Original and two photocopies
  - e) Gap Certificate if applicable
  - f) CUET PG Application form (2 Copies)
  - g) CUET PG scorecard (2 Copies)
  - h) GGV Registration/ Enrolment Form (2 Copies)
  - i) Four passport size photographs (white background preferable)
  - j) Migration, Character Certificate and Transfer Certificate, Original and two photocopies of each
