## **Instructions:**

- 1. All the candidates listed above are hereby invited for provisional admission in the B.COM. LL.B. 5-year Integrated Programme.
- 2. Among the candidates listed above, interested candidates, who wish to take provisional admission must pay the fee (₹ 7,100 for 1<sup>st</sup> Semester) through the Samarth portal only till 10<sup>th</sup> August, 2025.
- 3. The payment shall be made through the Samarth portal and no other payment method will be accepted for the purpose of provisional admission.
- 4. After making the payment, candidates must fill out the Google Form (link: <a href="https://shorturl.at/0MNLF">https://shorturl.at/0MNLF</a> or Scan QR code attached at bottom) to enable the department to confirm receipt of the fee.
- 5. Payment of the fee alone does not guarantee provisional admission. Candidates must meet the prescribed eligibility criteria and submit the required documents during physical verification, As notified by The Department later on.
- 6. Candidates who fail to pay the fee and do not comply with the instructions mentioned in points 1 to 4 will have their candidature cancelled. The vacant seats will then be offered to other candidates based on merit in the next round of admissions.
- 7. Candidates, who do not comply with the instructions mentioned in points 5, will have their candidature cancelled. The vacant seats will then be offered to other candidates based on merit in the 3rd round of admissions.
- 8. All the candidates must possess ABC Id at the time of admission without which the candidature will be cancelled.

- 9. All the candidates who will pay fee are also required to be present for physical verification (on the Dates as Notified by The Department, later on) along with following mentioned documents without fail:
  - a) 10<sup>th</sup>/HSC marksheet original and two photocopies
  - b) 12<sup>th</sup>/HSSC marksheet original and two photocopies
  - c) Caste/ PwD/ EWS/ Income certificate (if applicable) Original and two photocopies
  - d) Gap Certificate, if applicable
  - e) CUET UG Application form (2 Copies)
  - f) CUET UG scorecard (2 Copies)
  - g) GGV Registration/ Enrolment Form of B.COM. LL.B. (2 Copies)
  - h) Four passport size photographs (white background preferable)
  - i) Migration, Character Certificate and Transfer Certificate, Original and two photocopies of each
  - j) A Copy of Aadhar Card (Non-mandatory)
- 10. The Classes will commence from 21st August, 2025.
- 11. Hostel allotment will be carried out on the day of physical counselling, subject to the availability of seats.

Note: The vacant seat position will be Declared on  $20^{\text{th}}$  august 2025 after the physical verification. (If any)

Mere payment during online counseling does not entitle an applicant to confirmed admission. Provisional admission is subject to the condition that the candidate must fulfill the eligibility criteria and present the necessary supporting documents, as specified under Point No. 9 (including the original Transfer Certificate and Migration Certificate), at the time of physical verification. Failing to do so may result in the cancellation of the provisional admission.
