The Awardee is required to get admission and registration for regular and full time **Ph.D.** course in a University/Institution/College recognized by UGC at the first available opportunity **but not later than three years** from the date of issue of this certificate. University/Institution/College is requested to process for award of JRF based on this certificate, in accordance with the prescribed procedure.
- D. The tenure of fellowship is five years and it commences from the date of declaration of NET result, i.e., 22-02-2025 (or) from the date of admission under Ph.D. (or) from the date of joining Ph.D. programme, whichever is later.
