B. Period of Probation

You will be on probation for a period of **two years** from the date of your joining the Bank. During the probation period, you will be required to undergo training in any Branch / Office / Entity of the Bank or in any institution to which you may be deputed and the in-service training in the Bank. The Bank, may, however, at its sole discretion curtail or extend or dispense with the period of probation in any individual case.

Notwithstanding such period of probation including the period of extension, if any, the Bank may discharge you from the services of the Bank without assigning any reason for such discharge on giving one month's notice or payment of one month's emoluments in lieu of such notice. You will be confirmed in the services of the Bank only after satisfactorily completion of probation period and on receipt of confirmation of educational qualifications, community certificate (if applicable), satisfactory report on your antecedence and on the basis of evaluation of your performance in the Bank as satisfactory at periodical intervals during probation period.
